## Cape Cod Municipal Health Group Demographic Summary




- Total membership has decreased by 6% over the prior year
- Membership in the PPO and HMO plans account for 91% of members non senior plan membership .

## Cape Cod Municipal Health Group Total Medical Costs



- Total medical and pharmacy costs have increased by 4% over the prior year, similar to the network.
  - Medical costs have increased by 4% (vs. 4% network average)
  - Pharmacy costs have increased by 4% (vs. 0.2% network average)




## Cape Cod Municipal Health Group Total Medical Costs



 Cape Cod Municipal Health Group's PMPM in FY10 was higher than both the network and the BCBSMA municipal average.

• The difference in the account PMPM to the comparison groups was primarily due to higher medical claims.



## Cape Cod Municipal Health Group High Cost Claimants



- The increase in the overall PMPM was driven by an increase in the number of high cost cases over the period.
- The number of members who incurred greater than \$100K in claims rose from 53 to 65 and the percent of claims from 11.2% to 13.4%.

## Cape Cod Municipal Health Group PMPM Costs by Treatment Setting



- PMPM change was driven by increases across nearly all treatment settings.
- The PMPMS for both outpatient facility and professional settings were higher than both the network comparison and the municipal comparison group.

## Cape Cod Municipal Health Group PMPM Costs by Treatment Setting



- The outpatient facility PMPM increased due primarily to an increase in therapeutic radiology, pharmacy (administered drugs – typically chemotherapy), and diagnostic radiology.
- An increase in the PMPM for office visits drove the increase in the outpatient professional PMPM. This increase was due to both an increase in visits and in the cost per visit.
- Inpatient facility PMPM was driven by a slight increase in the rate of admissions and a more significant increase in the cost per admission. By types of service, maternity and medical drove the overall inpatient increase.
- The medical type of service included admissions for cystic fibrosis and strokes.

- The top 10 ETGs accounted for 31% of total costs.
- Of note is the increase in the rate of members with depression, hypertension and diabetes from the prior year.

## Cape Cod Municipal Health Group Pharmacy Summary



- Pharmacy utilization increased slightly but PMPM costs increased 4% as a result of a higher average cost per script.
- Generic utilization continues to improve and was at 73%
- Mail order utilization increased to 14%
- The top five therapeutic classes (by cost) were:
  - 1. Antidepressants
  - 2. Antihyperlipidemics (cholesterol drugs)
  - 3. Asthma Drugs
  - 4. Antidiabetics
  - 5. Analgesics Anti-inflammatory

#### Summary:

- Cape Cod Municipal Health Group membership decreased by 6%.
- There was a 4% increase in total medical & pharmacy costs PMPM.
- The PMPM for nearly all treatment settings increased with outpatient costs having the greatest impact on overall costs.
- A driver of the overall increase in costs was the increase in the number of members incurring greater than \$100K in payments.
- Rates of chronic disease related to lifestyle choices are high and worsening over time.
